Applications can only be submitted online via electronic system www.dogoffice.cz. All accepted applications will be confirmed with entry tickets. For registration it is necessary to create an account in the Dogoffice system, then in the section „MY DOGS“ you can insert your dog, in section „DOCUMENTS“ you have to add copies of both sides of the dog's pedigree including the part with a clearly and visibly stated owner. In this section it is also possible to add copies of working certificates or championship diploma for inclusion in the working or champion class. In case these documents are missing, the class of the dog will be automatically changed to Open.

After a successful registration you will receive a confirmation message, you will also see your application status in the section „APPLICATIONS“. After completing your registration the system will generate a variable symbol for payment. The application is only valid when having been paid!

Handling fees:

- Cancellation of an exhibitor by the 3rd closing date – CZK 100. After the 3rd deadline is no longer possible to cancel the application
- Changing class of the dog to another class as the request of the exhibitor to the third closing date – 100,- CZK. After the final deadline is no longer possible change the class!

Veterinary conditions:

- All the entered dogs must be clinically healthy.
- Dogs must have pet passport or veterinary certificate with valid vaccination against rabies.
- Dogs from EU and third countries must have valid EU Pet Passport and must meet the conditions by the EU Regulation 998/2003 from 26/5/2003
- All the time during the dog show the owners must supervise / take care of the dogs so that they do not cause any damage to other dogs or humans or themselves. Owner/handler is responsible of health status of his dog, keep the dog in accurate conditions to protect health of his dog.

Documents for participation at the show:

- Pedigree
- EU Pet passport

Classes: division into classes is governed by Show Regulation of CMKU and FCI and is indicated on the entry form. Color, sizes and type of hair of some breeds are judged separately in compliance with the provisions of FCI or by decision by ČMKU. Awarding of titles can not be entitled.

Expectancy: CAJC, CAC ČR, CAC ČMKU, Res. CAC ČR, CACIB, Res. CACIB

Titles: Best of Breed – BOB, Best of opposite sex – BOS, Best Junior in breed – BOJ, Best Veteran of breed – BOV, Junior Winner of FCI – JBIG, Junior Winner at the show – JBIS, winner of FCI group – BIG, winner of the day - BOD, winner of the show – BIS.

Competitions:

Junior Handling – age groups: I. 9–13 years, II. 13–17 years, to achieve group is counting by date of birth entered one day before the show. Compete can be only with a dog registered in the stud book recognized by the FCI, the dog may not be judged on the show. Assesses the performing dog quality is not important. Points earned in competition on national and international exhibitions may count yearlong, statewide competition.

Saturday – Best of National Breeds (BONB) – competition for all individuals Czech FCI recognized and FCI non-recognized breeds including Czechoslovakian wolfdog.

Best Puppy – To enter the competition, all males/ females who were honored at an exhibition in puppy class very promising I.

Best Veteran – competing of dogs, who received the title Best Veteran in breed BOV.

Best of Honour class – competing of dogs, who received Exc. 1 in honour class.

Best Couple – a male and a female of the same breed and variety presented at the show, owned or co-owned by the same person(s). The co-ownership must be confirmed by a record in the pedigree of both dogs.

Best Breeder's Group – 3 – 5 individuals of the same breed and variety, which have been judged at the show, which were born in the same kennel and which have at least two different fathers or mothers.

Junior Group Winner (JBIG) – competing by FCI groups. For all dogs, who received the title BOJ

Group Winner (BIG) – competing of BOB winners, judging by groups FCI

Junior Best of Day (JBOD) – competing of dogs, who won JBIG

Best of Day (BOD) – competing of dogs, who won the FCI groups

Junior Best in Show (JBIS) – competing of winners JBOD

Best in Show (BIS) – competing for dogs, who won BOD

General provisions: The exhibition is accessible to males and females of all breeds registered in the books recognized by the FCI that reached the day of the show the age required for class. Organizers are not responsible for damages caused by a dog or an exhibitor, or for dog loss or death during the exhibition. At the fairgrounds are not allowed to move freely dogs. **The exhibition will not be admitted dog with cropped ears and will not be judged.** Show is not open for females in season, females in the second half of pregnancy, nursing females and aggressive individuals. It is forbidden to treat the coat, skin or nose of the dog anything that changes their texture, color or shape. It is forbidden to treat the dog on the show grounds, using any substances or equipment. Allowed only cutting, trimming, combing and brushing. It is also forbidden to tie the dog on the table at the show. Violation of this provision may result in immediate expulsion from the show. Owners of the dogs awarded the title BOB are obliged to participate with their dogs in the final competitions. Exhibitors are required to comply with the provisions of the FCI Show Regulations and CMKU, these propositions and the instructions of Show Committee, which will undertake the filing. Exhibitor acknowledges that it is required to maintain order in the exhibition area. If the show does not take place due to force majeure, the fees will be used to cover the expenses. Taking puppies for sale at the show is prohibited. Organizer assumes no responsibility for not delivery entryforms. There will be random verification of the identity of your dogs (tattoo number or chip number).

Exhibitors at the CMKU show are responsible for the welfare of dogs. It is forbidden to expose a dog to a situation that could endanger his health or well-being, such as leaving him in a vehicle for extraordinary heat or winter, respectively behave in a rough way. Violations of this Regulation will result in exclusions from the following exhibitions.

Entry confirmations are available in the system www.dogoffice.cz about 7 days before the exhibition.

If you don't receive the confirmation, please contact the show office. An exhibitor agrees with publication of his address in the catalog.

Protest: A protest against any decision made by the judge is not admissible. A protest can be submitted for formal reasons such as violation of show regulation provisions and proposition provisions. The protest must be submitted in written form, against a deposit of 1600 CZK, during the course of the show. If the protest is found to be unjustified, this deposit will be forfeited to the organizer of the show.
