ONLINE ENTRIES www.dogoffice.cz Entry takes place via the online system www.dogoffice.cz Each user must have their personal account set up in the system. In the section My dogs you will establish your dogs and attach to them the necessary attachments (Pedigree of both parties, including the party where the owner is listed). The owner registered in the pedigree must be the same as the username of the account in [dogoffice.cz](http://www.dogoffice.cz) ie. if the dog is co-owned, an account in the [dogoffice.cz](http://www.dogoffice.cz) must be established under the same names.

After a successful registration you will receive a confirmation message, you will also see your application status in the section „APPLICATIONS“. After completing your registration the system will generate a variable symbol for payment. The application is only valid when having been paid!

The organizer reserves the right to cancel unpaid entries without urgency. A dog can only be entered in one class. Entry forms are available in the system www.dogoffice.cz about 7 days before the exhibition.

Handling fees: – Cancellation of the entry an exhibitor by the last closing date – half of your entry fee. After the final deadline is no longer possible to cancel the entry! – Reclassification dog to another class at the request of the exhibitor to the last closing date – 15 EUR.

Veterinary conditions:

- All the entered dogs must be clinically healthy.
- Dogs must have pet passport or veterinary certificate with valid vaccination against rabies.
- Dogs from EU and third countries must have valid EU Pet Passport and must meet the conditions by the EU Regulation 998/2003 from 26/5/2003
- Il the time during the dog show the owners must supervise / take care of the dogs so that they do not cause any damage to other dogs or humans.

Documents for participation in the exhibition:

- Pedigree
- EU Pet passport
- Entry confirmation

Classes: division into classes is governed by Show Regulation of CMKU and FCI and is indicated on the entry form. Color, sizes and type of hair of some breeds are judged separately in compliance with the provisions of FCI or by decision by ČMKU. Awarding of titles can not be entitled.

Expectancy: CAJC, CAC ČR, CAC ČMKU, Res. CAC ČR, CACIB, Res. CACIB, CACIB-J, CACIB-V

Titles: Best of Breed – BOB, Best of opposite sex – BOS, Best Junior in breed – BOJ, Best Veteran of breed – BOV, Junior Winner of FCI – JBIG, Junior Winner at the show – JBIS, winner of FCI group – BIG, winner of the show – BIS.

Competitions:

Junior Handling – age groups: I. 9–13 years, II. 13–18 years

Best Minor Puppy – To enter the competition, best male or female from the competition advances very promising I.

Best Puppy – To enter the competition, all male or from the competition advances very promising I.

Best Veteran – competing of dogs, who received the title Best Veteran BOV.

Best of Honour class – competing of dogs, who recived Exc. 1 in honour class.

Best Couple – a male and a female of the same breed and variety presented at the show, owned or co-owned by the same person(s). The co-ownership must be confirmed by a record in the pedigree.

Best Breeder's Group – 3 – 5 individuals of the same breed and variety, which have been judged at the show, which come from the same kennel and which have at least two different fathers or mothers.

Junior Group Winner (JBIG) – competing by FCI groups. For all dogs, who received the title BOJ

Group Winner (BIG) – competing of dogs with titule BOB, judging by groups FCI

Junior Best of Day (JBOD) – competing of dogs, who won JBIG

Best of Day (BOD) – competing for dogs, who won the FCI groups

Junior Best in Show (JBIS) – competing of winners JBOD

Best in Show (BIS) – competing for dogs, who won BOD

Instructions for application completion: Applications should be completed in block letters. Each dog has its own application. Illegible applications will not be accepted. For incorrectly completed application organizer is not responsible. For each application, the entryform must include a photocopy of both sides of pedigree. In the case of a payment by postal service, support the entryform at least with a photocopy of payment. A dog can be entered only in one class. If the application is missing attached photocopy of proof that the dog meets the conditions for the working or champion class, will be placed in the open class. To access the honor class is required to prove title to justify the inclusion of a dog in this class. To documents sent after the third deadline will not be considered. Acceptance of a dog to the show will be about 10 days before the show electronically send to your e-mail address. If you don't receive the confirmation, please contact the show office. An exhibitor agrees with publication of his address in the catalog.

General provisions: The exhibition is accessible to males and females of all breeds registered in the books recognized by the FCI that reached the day of the show the age required for class. Organizers are not responsible for damages caused by a dog or an exhibitor, or for dog loss or death during the exhibition. The fairgrounds are not allowed to move freely dogs. During the show will be a random inspection of the identity of dogs (tattoo nr./chip) according to the regulations of CMKU. **The exhibition will not be admitted dog with cropped ears and will not be judged.** Show is not open for females in the second half of pregnancy, nursing females and aggressive dogs. It is forbidden to treat the coat, skin or nose of the dog anything that changes their texture, color or shape. It is forbidden to treat the dog on the show grounds, using any substances or equipment. Allowed only cutting, trimming, combing and brushing. It is also forbidden to tie the dog on the table at the show. Violation of this provision may result in immediate expulsion from the show. Owners of the dogs awarded the title BOB are obliged to participate with their dogs in the final competitions. Exhibitors are required to comply with the provisions of the FCI Show Regulations and ČMKU, these propositions and the instructions of Show Committee, which will undertake the filing. Exhibitor acknowledges that it is required to maintain order in the exhibition area. If the show does not take place due to force majeure, the fees will be used to cover the expenses. Taking puppies for sale at the show is prohibited. Organizer assumes no responsibility for not delivery entryforms. If more than 80 dogs are entered for the judge, there is no need to write show reports after agreement with the organizer. Leaving the dog in a vehicle without human supervision - This is allowed only exceptionally and for a short time period. In this case, the dog must be provided with sufficient air, space or light, as well as a suitable ambient temperature (eg functional air conditioning in summer and heating in winter). Longer keeping the dog in a confined space of the vehicle can be considered as a cruelty.

Exhibitors at the CMKU show are responsible for the welfare of dogs. It is forbidden to expose a dog to a situation that could endanger his health or well-being, such as leaving him in a vehicle for extraordinary heat or winter, respectively behave in a rough way. Violations of this Regulation will result in exclusions from the following exhibitions.

Protest: A protest against any decision made by the judge is not admissible. A protest can be submitted for formal reasons such as violation of show regulation provisions and proposition provisions. The protest must be submitted in written form, against a deposit of 2200 CZK, during the course of the show. If the protest is found to be unjustified, this deposit will be forfeited to the organizer of the show.

Photos and videos can be taken at the exhibition. By visiting the event, the viewer accepts that they may be subject to photography and records. The photographer must be notified of any objections to this.
